

Assistant Professor (JOB#12540) Arizona State University Department of Psychology

The Department of Psychology at Arizona State University invites applications for a tenure-track Assistant Professor in Clinical Psychology beginning August 2019. Applicants at the entry level or advanced-assistant level with expertise in child-clinical psychology are encouraged to apply. The successful candidate will be expected to make scholarly contributions in child-clinical psychology, mentor graduate students, teach advanced courses in her/his specialty area, contribute to teaching the core clinical curriculum at both the graduate and undergraduate levels, and participate in service to the department, university and profession as appropriate.

The clinical psychology graduate program adheres to the Clinical Science training model. Several clinical faculty conduct research on the prevention of child mental health problems among at-risk children. The Research and Education Advancing Children's Health Institute, which is part of the Psychology Department, focuses on developing, evaluating and disseminating evidence-based prevention programs. Ongoing collaborations exist within the clinical, developmental, social and quantitative faculty in the Psychology Department, across departments and schools on campus, and with multiple agencies and medical centers in the community. It is anticipated that the successful candidate will join and extend such collaborations.

The requirements for this position include: (1) a Ph.D. in Clinical Psychology at the time of appointment; (2) evidence of scholarly contributions in child-clinical psychology; and (3) evidence of quality teaching relative to the candidate's level of experience. Demonstrated success reaching out to diverse communities or meeting the needs of diverse student populations is desirable.

Initial deadline for receipt of complete applications is November 1, 2018. If not filled, review of complete applications will continue every two weeks thereafter until the search is closed. A background check is required for employment.
